 - i) Preparation of Bank Reconciliation statement for the Banks.
 - ii) Making of any adjustment entries, necessary for finalization of Accounts.
 - iii) Preparation of Trial Balance along with Group Trial Balance.
 - iv) Preparation of Deprecation Statement, incorporation of entries as per Actuarial Valuation report, provision of doubtful debts and advance etc.
 - v) Preparation of Balance Sheet, Profit & Loss Statement, Cash Flow statement, Statement of change of Equity along with necessary schedules, Notes to Accounts, ascertainment of contingency, foot notes and segment wise result of each financial year etc. as applicable to the Company under the Companies Act, 2013.
 - vi) Liaison and co-ordination with Statutory Auditors, CAG Auditors
 - vii) Any other work necessary for completion of the job as may be assigned from time to time.

- 5. Time schedule of Work:- The job must be completed within 1 (one) month from the issue of work order.
- 6. The fees to be charged for the work is to be quoted in the space provided in Annexure-A (Financial Bid).
- 7. The quotation should be submitted in two parts; Part-A (Technical bid) and Part-B-(Financial bid, as per Annexure-A & mentioned in Sl. No. 6 above) in separate sealed packets. Both the sealed packets (Part-A & Part-B) should be put in a main cover duly sealed and submitted in Tender Box located at Head Office of WSFL at Baguiati, Kolkata. The name of the work, tender Ref. No. along with the date and time of submission should be clearly super scribed on the top of each of the sealed packets (Part-A & Part-B) as well as on the Main Cover, in absence of which the tender may be rejected.

The evaluation of the proposals shall be carried out in two stages. In the first stage, evaluation of the technical proposal (in sealed packet PART-A) will be taken up. In the second, stage evaluation of the financial proposal (in sealed packet PART-B) of the technically qualified bidders will be taken up. Discretion of the Tender Committee towards selection of bidder will be final and binding upon the bidder. In case of any disputes, the decision of the Tender Committee will be final and binding upon the bidder.
