Eligibiity / Qualification Criteria:-

- 1. The bidder should possess a registration as a firm under Proprietorship / Partnership or a firm, with any Government Authority. (Certificate issued by shops and Establishment registration on Service Tax (GST) Registration or any other issuing authority).
- 2. Agencies without having valid registration and authorization will not be allowed to participate in the bid.
- 3. All bidders must enclose GST registration certificate along with the tender document.

Instructions and conditions :- -

- All the rates shall be filled up in figures as well as words in the schedule of rates to be quoted by the bidders in the schedule of rates to be quoted by the bidders in English language only without fail. In case of variation, higher of the amount quoted in words and figures will be accepted as Final bid / quote.
- 2. The rates against each item shall be filled up only in the tender form issued to the tenderers.
- 3. The tender document (all pages) shall be duly signed and stamped with firm's seal by the bidder.
- 4. No paper sheet shall be detached from the tender document.
- 5. The tender shall be accompanied by the EMD for the specified amount.
- 6. The tender shall be liable for rejection if any of the above said requirement are not complied with.
- 7. EMD for the purpose of said document has been fixed as Rs.500/-(Rupees five hundred only) and the amount shall be paid through demand draft drawn on any Nationalized Bank favouring Westinghouse Saxby Farmer Limited payable at Kolkata. The same shall be submitted by bidder alongwith tender document. The tender not accompanied with the full value of prescribed EMD will be summarily rejected. Late tenders will not be accepted. EMD does not hear any interest and will be returned to unsuccessful bidder.
- 8. The bidder shall clear the material out of the premises at its own arrangements / cost etc.
- 9. All the intending bidders may inspect the scrap/waste put up for disposal during the working hours of WSFL. In any case they will be presumed that they have inspected, verified and satisfied themselves about the material before quoting.
- 10. Bidder can bid for any one or more categories of material. However, the bidder quoting highest bid for any one or more than one item shall be required to lift the entire quantity of material at his own cost which his bid has been found highest.
- 11. Tender may be quoted in full or part on item wise basis. Quantities of scrap/waste may be divided equally among parties quoting same rate for same item at the discretion of WSFL, Titagarh.
- 12. WSFL reserves the right to cancel the tender for scrap/waste or withdraw any lot or part thereof from the rate without assigning any reason thereof.
- 13. Taxes and duties that may be levied by the Govt. will be extra as applicable and shall be borne and deposited by the highest successful bidder before lifting of material.
- 14. No complaint whatsoever will be entertained after the tenders are submitted or before or after materials are lifted. No request for samples or inspection after submission of the tender will be accepted.
- 15. The items shall be sold to the H1 bidder i.e. the bidder that offers Highest Price.
